#### 21/54 Apologies:

Apologies were received and accepted from Councillors Mr. B. Lyon, Mr. A. Brown, Ms. S. McIntosh and Mr. P. Sharp.

# 21/55 Disclosure of Personal or Prejudicial Interests.

No interests were declared.

#### 21/56 Minutes of Meeting held on June 8th. 2021.

The minutes of the meeting having been circulated were approved and signed by the Chairman as a true record.

#### 21/57 Matters Arising.

# (a) Playing Field - path repair (21/42(a))

It was noted that the work had been carried out and several of the other paths had been 'dressed' free of charge.

#### (b) Allotment – sale of land (21/42(b)).

A report from the Council's solicitors stated that the Housing Association solicitor had informed them that the work was in the 'to do file' and it was hoped to deal with it soon.

#### (c) Community Environment Project (21/41(c)).

Following discussions with the new officers overseeing the management of the project it had been decided to apply again and the Clerk had received confirmation that the application had been approved and that a grant of £1,500 had been made subject to the same regulations as the previous year.

#### (d) Carradine streetlight (21/41(d)).

Clerk reported that in spite of numerous emails and telephone calls he had still not been able to make contact with Mr. Garry Johnson at E.ON.

## (e) Play Area Repairs (21/41(e))

The planned work on both sites had been completed with apologies from Mr. Ray Parry for the delay which had been caused by Covid restrictions and difficulty in obtaining materials.

#### (f) Church Close/Park Avenue Highways problems

The response received from Ms Victoria Doran (The Area Highways Officer) was considered and it was agreed that the Clerk should arrange a meeting date.

#### (g) Community Service Awards (21/47(iii)

Three additional nominations had been received and it was agreed that the Chairman would publish details of the award on the local Community Facebook. Clerk to advise the Commanding Officer at RAF Shawbury of the date and ask him if he or a Senior Colleague would attend and present the awards. As in the past Certificates and Plaques would be presented to nominees.

#### 21/58 Correspondence.

Members considered the attached list of correspondence received by the Clerk since the last meeting and noted that, where necessary, appropriate actions had already been taken or responses made.

A quotation of £950.00 from JST Services for the construction and installation of a metal picnic table in The Glebe to replace the one destroyed by an arson attack was considered and approved. The Chairman pointed out that similar commercial units plus delivery and installation costs would be in excess of this.

#### (b) Other Issues:

## i. Highways:

The Chairman suggested that Shropshire Council should consider constructing a 'pull in' area on the A53 halfway between Shawbury and the Battlefield roundabout, which would allow slow moving vehicles, especially tractors with trailers, to pull off the road and allow other traffic to move more freely. ii. Streetlights.

No issues raised.

#### iii. Other Reports:

Councillor K. Pickering reported that he had spent time in the Burial Ground removing weeds from the gravel cremation burial areas and was keen to continue undertaking further activities there. He was thanked for his endeavour and he agreed to liaise with the Chairman over future projects.

#### (b) RAF Shawbury:

- Lt. M. Peters issued hard copies of Aries magazine and gave an update on activity at the base highlighting:
- (a) The plans for the 10km Charity race being held on September 5<sup>th</sup>. which was open to everyone.
- (b) A reminder that Gliding Club activity would move from Saturdays to Sundays after August 28<sup>th</sup>.
- (c\) The Horse Rider Awareness Campaign being carried out. The Chairman confirmed that the information had been given wide publicity and was proving to be very valuable.

## (c) Shropshire Council:

Shropshire Councillor S. Jones reported that

- (a) It was currently quite a quiet situation with the new administration settling in.
- (b) Additional finance was being made to deal with the poor state of the roads across the County, with local firms being encouraged to bid for minor projects leaving Kier to deal with the major issues.
- (c) The indication was that the Council would proceed with the Shrewsbury Northern Link-road in spite of the very high level of objection received.
- (d) No decision had been made regarding the provision of a third waste bin for plastics etc.
- (e) The proposed housing development plan was being considered by the full Council on July 15<sup>th</sup>. and if approved would be forwarded to the Government Inspectorate for consideration and comment and it would probably take twelve months for them to respond.
